Under the generous auspices of Cardiff Metropolitan University, and from September 3rd to the 5th, once again we will be able to engage in enthusiastic and stimulating philosophical dialogue with our colleagues, renew our commitment to the discipline and to one another, and welcome new faces to our vibrant community. Alun Hardman and his extremely well organized team, in close collaboration with our very capable Conference Chair John Gleaves, have been working very diligently for many months to ensure that conditions are the best possible to facilitate this. As of today, there are 95 papers accepted, quite a few with joint authorship. On your behalf, I express much gratitude to all four Members-at-Large who so thoroughly fulfilled their duties (Kenneth Aggerholm, Chad Carlson, Teresa Lacerda, and Ana Zimmermann). There will be two keynotes this year. David Papineau, Professor of Philosophy at King's College London and the Graduate Center of City College of New York, will deliver the opening keynote: "More than a Game." He will challenge the 'Suitsian Dogma' according to which the value of sport derives from overcoming arbitrary obstacles. Paul Gaffney, Chair of Philosophy at St. John's College in New York and incoming editor for the Journal of the Philosophy of Sport, will treat us with a paper entitled "Playing with Cheaters." We can always learn more about how to handle, philosophically and otherwise, the tricksters.

As for the social program, things kick off, or rather tee off, with a game of golf on the 2nd. Contact Mike McNamee should you be inclined to such endeavors. Other highlights include a performance by the Welsh Choir of the year, a Rugby game between Wales and Italy, and a city tour of Cardiff and the National History Museum. The Welsh coastline is dramatic and beautiful, and while the water's temperature may not be as inviting as northern Brazil's, it still offers plenty of opportunities for seashore walks or water-based activities.

IAPS Conference, 2015

With temperatures (for those of us in the northern hemisphere) heating up, so too is the organizing of the 2015 IAPS conference. Alun Hardman, along with his administrative assistant Jessica Brainch, are busy preparing to welcome sport philosophers from around the world to Cardiff Metropolitan University from September 2-5, 2015. Their effort deserves much thanks

In addition to witnessing the work done to produce an ideal venue, I am in the privileged position to see the fruits of so many individual's philosophical efforts as I have spent the last few months with the abstracts and organizing the program. I can safely say that this year's conference promises diverse and interesting works among the highest quality I can remember. I will provide details of the conference program in my Conference Chair Report, but I am most excited that we have accepted papers from scholars in Africa, the Middle East, Asia, Australia, Europe, South America and North America. With nearly 100 papers and scholars from six continents, this promises to be an intellectually rich program with papers covering many vibrant subfields of sport philosophy.

As of July 3, there were 95 accepted and confirmed papers. Because of co-authorship, there were 119 authors/presenters. The breakdown in terms of country of origin, and standing, whether student or faculty will be determined once the program and final tally is done in August. This year Easychair was adopted on a trial basis, but as is, it has proven to be quite difficult to extract information for the compilation of the abstract book. The executive will discuss options in this regard at the Executive Meeting.

As far as the program is concerned, there will be two keynote presentations, the opening one by David Papineau from King's College, and another by Paul Gaffney of St. Johns College New York. In addition there will be a roundtable and panel with some elite sportspeople, among them Nicole Cooke, former cycling world champion, and two other panels, one on the social impact of sport and another one on Philosophical Approaches to Skill in Sport and Physical Activity.

Online registration is open, with Early Bird rates being offered until July 31st. Presenters are reminded that they need to be members in good standing before August 1st

As we prepare for the 2015 conference, it is also worth commenting on IAPS conference norms and etiquette. IAPS has always valued inclusiveness and friendly inquiry and we hope to continue this tradition of collegial scholarship.
