## President's Message –

*Cesar R. Torres, President*

Greetings from Western New York! I hope that 2011 is off to a great start for all of you. For IAPS, 2011 promises to be another year with plenty of activity. I am pleased to report several developments on different aspects of the Association's life.

As you may recall, late in 2009, IAPS decided to move to a calendar year membership. Memberships expiring on 30/09/2010 were automatically extended to 31/12/2010. This means that 2011 is the first time that memberships are renewed under the calendar year cycle. Human Kinetics sent three renewal notices on the Association's behalf (November 15, 2010; December 10, 2010; and January 17, 2011). In addition, I sent personalized notes to those who had not renewed their memberships by the end of last month. Fortunately, memberships have been renewed at a steady pace and the move to a calendar year membership seems to be working well. The planning for the 39<sup>th</sup> Annual Conference of IAPS to be held in Rochester, New York, September 8-11, 2011 and hosted by The College at Brockport, State University of New York is well underway. Last month, the conference organizers launched the conference's website. Please visit the website at <http://www.brockport.edu/iaps2011> for important information about the event. You can now register for the conference and reserve rooms at the Hyatt Regency Rochester, where the event will be held. On a related matter, take note of the second call for papers for this year's annual conference included in this newsletter. The deadline for abstracts is April 1, 2011. Contributors will be notified about the status of their abstracts by May 16, 2011. Once the review process is completed, a tentative program will be posted on the IAPS website. Information regarding the Student Travel Award will be posted on the website as well. I want to remind you that this year's program will include a *Warren P. Fraleigh Distinguished Scholar Lecture* by Jim Parry. In addition, the program will feature a keynote address by J.S. Russell.

I would also like to remind members that late last year, the Executive Council decided to create the R. Scott Kretchmar Student Essay Award. IAPS hopes students will take advantage of this new opportunity and is looking forward inaugurating the award at this year's annual conference.

R. Scott Kretchmar himself has continued the fundraising effort among IAPS past-presidents and all members for the Student Travel Award Fund. Students are the future of both IAPS and the philosophy of sport, and participation in our annual conference can and should be an important part of their education. IAPS held a session at the Eastern Division of the American Philosophical Association on the afternoon of December 28, 2010 in Boston, Massachusetts. The session was organized by Joan Grassbaugh Forry. Unfortunately, terrible weather conditions did not allow Joan or Pam Sailors

to fly out and make it to Boston. However, Clancy Smith and Steven Weimer delivered papers and held the session. In addition, there will be an IAPS session at the Pacific Division of the American Philosophical Association on the evening of April 20, 2011 in San Diego, California. The session is organized and will be chaired by Doug McLaughlin, and Joan Grassbaugh Forry, Keving Krein, Bill Morgan, and Stephen Schmid will present papers. I want to thank all of those who made these sessions possible for promoting the philosophy of sport all across the United States.

This fall, a number of important positions in the Executive Council will become available: President, Newsletter Editor, Website Editor, two Members-at-Large, and one Honors, Awards and Future Sites Committee position. I would like to urge all members to please give serious consideration to this year's elections and the call for nominations included in this newsletter. IAPS has capable and committed members who would be able not just to fill these positions but, more important, to make significant contributions to the Association. Last year, the Executive Council nominated Mike McNamee as a keynote speaker for the International Convention on Science, Education, and Medicine in Sport 2012 (ICSEMIS 2012). I am very pleased to announce that the nomination has been accepted. Congratulations Mike! ICSEMIS 2012 will be held in Glasgow, Scotland from July 19-24, 2012. Furthermore, the Executive Council proposed a number of topics for invited symposia at ICSEMIS 2012. Although the event's scientific program is still being discussed, IAPS is working hard to ensure that the philosophy of sport has a strong presence at ICSEMIS 2012.

Finally, as it noted in the last issue of the Newsletter, the current publishing contract with Human Kinetics expires on October 31, 2011. J.S. Russell, editor of the *Journal of the Philosophy of Sport*, is in charge of negotiating a new publishing contract. We will keep you informed in this regard.

## **Call for Papers IAPS**

The International Association for the Philosophy of Sport invites the submission of abstracts to be considered for presentation at the 39th annual 2011 IAPS meeting. The conference will be held September 8-11, 2011 in Rochester, New York (USA).

Abstracts are welcome on any area of philosophy of sport, including metaphysics, epistemology, aesthetics, and ethics, and from any theoretical approach, including analytic philosophy and critical theory. While IAPS recognizes, values, and encourages interdisciplinary approaches and

methodologies, acceptance is contingent on the philosophical content of the project. Emerging scholars are encouraged to submit works in progress.

A Program Committee of three IAPS peers will review abstracts. Contributors will be notified about the status of their abstracts by May 16, 2011.

Proposals for round table and panel discussions, including a tentative list of participants, are also welcome and should follow the same format as paper abstracts.

## **R. Scott Kretchmar Student Essay Award**

Abstracts should be 300-500 words long, in English, and must be received by April 1, 2011. Please, follow the following instructions (incomplete proposals will be returned). Provide:

1. Name, E-mail, current position, and employer
2. Title of Program
3. Key Words (three to five)
4. Primary Content Area/s (choose no more than 2)
  - a. Ethics
  - b. Metaphysics
  - c. Aesthetics
  - d. Epistemology
  - e. Phenomenology
  - f. Comparative
  - g. Applied
  - h. Comparative
  - i. Other (explain)
5. Indicate special Audio-Visual requirements (computer & projector will be provided)

The preferred mode of submission is by e-mail.

## **Call for 2011 Executive Council Nominations**

The following positions will become available this fall: President, Newsletter Editor, Website Editor, two Members-at-Large, and one Honors, Awards and Future Sites Committee position.

*Nominations must satisfy a number of conditions:*

1. Each nomination must include a nominator, a seconder and a nominee.

2. The nominator, seconder and nominee must be members of IAPS (note that for election onto the Honors, Awards and Future Sites Committee requires IAPS membership of three years or more)
3. Nominations must reach Mike Austin by 5 June 2011 at [mike.austin@eku.edu](mailto:mike.austin@eku.edu)
4. The seconder and nominee must acknowledge they will second or accept, respectively, the nomination by sending an email to that effect to Mike Austin.
5. The nominee is advised to supply a brief biography (no more than 200 words) at the time of nomination.

**Handy Hint:** The easiest way to complete the nomination is for the nominator to copy the original nomination email to both the seconder and the nominee who can then use 'reply all' to acknowledge acceptance and attach the brief biography.

Once the nomination is complete, Mike Austin will forward an email to the nominator, seconder and nominee. Please be diligent in fully completing the nomination process.

## **Call for IAPS Scholarship Nominations**

The Honors, Awards & Future Sites Committee seeks nominations for the Warren P. Fraleigh Distinguished Scholar award and the Distinguished Service award.

### **Warren P. Fraleigh Distinguished Scholar Award**

The recipient must have contributed eminent manuscripts to the philosophic literature concerning sport for at least five years. The recipient need not be a member of the Association. The recipient of this award will receive a certificate commemorating her/his achievement, and will be invited to present an original essay at an Annual Meeting following her/his selection in the form of the Warren P. Fraleigh Distinguished Scholar Lecture.

### **Distinguished Service Award**

The recipient must have made sustained and meaningful contributions to the Association through active participation and leadership. The recipient must have contributed to the Association for at least ten years and must have been a member for at least the same number of years. The recipient will receive a certificate commemorating her/his achievement.
