As already mentioned, I am looking forward to the 40th IAPS annual conference, September 12-15 2012, at the beautiful venue of Porto (Portugal. Please note the fast approaching abstract deadline of April 2nd. We are very grateful to Jesús Ilundáin-Agurruza for all his hard work in preparing what will be another excellent IAPS conference programme. The conference website is now up and running and I encourage you all to submit abstracts and start making plans for Porto. Teresa Lacerda and the local committee are doing an excellent job with the organization and we thank them for this work.

I am delighted to announce that IAPS' 41st annual conference will be hosted by Fullerton's Department of Kinesiology at the California State University in conjunction with the Centre for Sport Performance 4-8th September 2013. My thanks to John Gleaves for his excellent proposal and the work of the Honours and Future Sites Committee in the process of providing the IAPS with a venue for next year's conference. We encourage members who are interested in hosting IAPS in the future to contact us to discuss the process.

Another development concerns the website. I'd like to thank Emily Ryall who has been working on updating and redesigning the website. The main changes are a simplified structure with fewer tabs at the top and an easy to access conference proposal form. We also have now embedded buttons that link to our social media sites such as Facebook and Twitter.

Thanks to the hard work of John Russell and Charlene Weaving, it looks like we are finally the other side of the transition period from Human Kinetics to Routledge as publishers of our Journal. I am hoping that glitches with membership, access to back issues and so forth will now lessen as the new order beds in. Part of this process involved IAPS becoming incorporated. John and Charlene will give more details of the implications and benefits in their reports below.

This fall, a number of important positions in the Executive Council will become available: Secretary Treasurer, Conference Chair, Journal Editor, two Members-at-Large, the Elections Chair position and one member of the Honours and Future Sites committee. I would like to urge all members to please give serious consideration to this year's elections and the call for nominations included in this newsletter. IAPS has capable and committed members who would be able not just to fill these positions but, more important, to make significant contributions to the Association. Later this year Mike McNamee will be a keynote speaker on behalf of IAPS at the International Convention on Science, Education, and Medicine in Sport 2012 (ICSEMIS 2012). ICSEMIS 2012 will be held in Glasgow, Scotland from July 19-24, 2012. Furthermore, the Executive Council proposed a number of topics for invited symposia at ICSEMIS 2012 which have been accepted and will feature on the conference programme:

Symposium1. Violence in Sport chaired by Jim Parry featuring Danny Rosenberg and Hazel Hartley.

Symposium 2. The Ethical and Aesthetical Dimensions of Media Coverage in Sport featuring Irena Martinková and Anthony Mark Cutter.

Symposium 3.Multiculturalism and Governance in Sport chaired by Sigmund Loland and featuring Gertrud Pfister and Marc Esser-Noethelics.

Symposium 4. Too fast to be Female: Caster Semenya and the politics of gender verification in sport chaired by Lisa Edwards and Paul Davis with Cara Aitchison and Beccy Watson.

There are other Philosophy of Sport symposia at the ICSEMIS conference sponsored by the British Philosophy of Sport Association featuring a number of our members as well as other philosophy of sport presentations. I will be attending the conference and seek to promote philosophy of sport in general and IAPS in particular.

At the General Business Meeting in Rochester 2012, John Russell's proposal to increase the number of members on the JPS editorial board, which would require an amendment to the constitution, led to the formation of an ad-hoc committee to evaluate IAPS entire constitution. The committee chaired by Pam Sailors have been working diligently on this task and they hope to have a final proposal ready for the Exec in the next few months. I would like to thank Pam, Leslie Howe, Vegard Fusche Moe and Scott Kretchmar for their work on this important task.

The Honour, Awards, and Future Sites Committee is seeking nominations for the *Distinguished Service Award* and the *Distinguished Scholar Award*. IAPS is fortunate to have many dedicated members who have made noteworthy contributions to its mission and to the literature over the years. We are pleased to begin our renewal campaign now that the transition to Routledge has been finalized. We encourage everyone to renew their memberships at your earliest convenience. To renew your membership, visit the Association's website at www.iaps.net and click "Join IAPS" and then "Renew your IAPS membership."

Let us remind you that membership of IAPS includes print and electronic issues of the *Journal of the Philosophy of Sport* as well as electronic access to back issues. Once you have renewed your membership, you will receive information on how to access back issues of *JPS*. You will also have electronic access to a second journal published by Routledge. Additionally, members have access to the association's newsletters.

Part of your membership goes to pay for the daily operation of IAPS. In this regard, it is used to cover the cost of the Association Management Agreement with Human Kinetics.

Members have on-line access to the journal now at http://www.tandfonline.com/rjps. Nearly all the content from past issues has been posted. I expect the remaining issues and articles to be posted imminently (the fall 2011 issue has not yet been posted, as of this writing). The arrangements for

Nominations must satisfy a number of conditions:

- 1. Each nomination must include a nominator, a seconder and a nominee.
- 2. The nominator, seconder and nominee must be members of IAPS (note that for election onto the Honors, Awards and Future Sites Committee requires IAPS membership of three years or more)
- 3. Nominations must reach Mike Austin by 15 June 2012 at mike.austin@eku.edu
- 4. The seconder and nominee must acknowledge they will second or accept, respectively, the nomination by sending an email to that effect to Mike Austin.
- 5. The nominee is advised to supply a brief biography (no more than 200 words) at the time of nomination.

Nomination Procedure

Nomination Procedure: The easiest way to complete the nomination is for the nominator to copy the original nomination email to both the seconder and the nominee who can then use "reply all" to acknowledge acceptance and attach the brief biography. Once the nomination is

complete, Mike Austin will forward an email to the nominator, seconder and nominee. Please be diligent in fully completing the nomination process.

Note: This year the voting will be done using an online voting tool, so that votes will be anonymous. Look for instructions in the July 2012 IAPS Newsletter regarding the procedure.

It is my pleasure to remind you that April 2, 2012 is the deadline to submit abstracts for the 40th IAPS annual conference, September 12-15, at the beautiful venue of Porto (Portugal). You may find more information, including guidelines for abstracts and the R. Scott Kretchmar Student Essay Award, as well as travel and venue information at the conference website: http://iaps2012.fade.up.pt (Alternatively you may check IAPS's website: http://www.iaps.net)

This will be regularly updated as information becomes available. Onsite conference organizers Teresa Lacerda, João Lima, and the rest of organizing committee are hard at work to ensure that this will be a wonderful and successful event. They are making pertinent calls for papers in Portugal and the Iberian Peninsula. The plan is to have concurrent sessions in English, Portuguese, and Spanish.

Next follow details regarding activity conducted to publicize this year's conference since the first call for papers went out in October.

Posts and announcements were made in the following lists and organizations:

- **IOC's website** –both a conference announcement and a modified CFP emphasizing Olympic Themes (as requested by the IOC).
- Phil Updates –a widely followed list that serves US, UK, and English fora
- **Phil-Sport list** –it serves IAPS, BPSA, EAPS members
- **H-Sport list**—historians of sport are its main users
- NASSM –concerned with issues in sports management
- NASSS –focused on sociological aspects of sport
- British Olympic Committee –both a conference announcement and a CFP

The call for papers (along with the website information and the conference poster) was sent to:

- All who submitted abstracts for IAPS 2012 (not just participants)
- A number of individual emails to colleagues with an interest in sport not covered by any of the above

On the Iberian side of things:

- A call for papers and announcement were made in *Dilemata*, a widely read Spanish practical ethics magazine with online and print editions
- A number of faculties of the Spanish physical education university system, INEFand Spanish researchers were contacted.

As always I am open to your suggestions.

May I also suggest that you "spread the word" among colleagues of yours or organizations you are acquainted with that I have missed (or let me know who/where and I will be happy to contact them).

Finally, I would like to make a personal request: please, *encourage your own students to submit abstracts* (and help them with the process). Last year we had a very heartening record number of student presenters that made up almost a fourth of total presentations. There is some financial support from IAPS for those students who apply for the Student Travel Award. However modest the sum may be, it brings with it the honorary accolade of being an award (always relevant when it comes to securing further financial support in the way of grants or a future job).

I look forward to communicating with you in the coming months and, above all, to see you in beautiful Porto in a few months' time.
